Instructions for authors

All papers must be supplied in electronic form and authors are asked to comply with our guidelines below to ensure a standard layout throughout the Conference Proceedings.

We would appreciate if you carefully following the instructions received from the publishers and detailed below.

Please note the following:

- the page size should be A4;
- each page should have clear margins of 2.5cm (top), 2.5cm (left and right) and 2.5cm (bottom);
- pages should not contain page numbers, running heads or footlines;
- all articles must contain an abstract prepared according to the instructions from abstract template provided on the website <http://www.dgt.uns.ac.rs/ctth/2017/instructions.php>
- The text of your article should start on the same page as the abstract. Any Acknowledgments should be placed immediately after the last numbered section of the paper, and any appendices after the Acknowledgments section.
- The paper should not exceed 10 pages
- The paper body should be written in Times New Roman, size 12, 1.5 spaced
- First level headings should be Bold, Times New Roman 12, second level heading Bold, Times New Roman, 10, third level headings Times New Roman 10, Italic. Heading should not have numbering.
- Figures and tables are placed within the text, not placed at the end of the document.

References

The surname of the author and the year of publication appear in parentheses after the citation, for example (Pivac, 2010). If more than one publication by the same author appear in one year, they must be distinguished by an a, b, etc., for example 2001a, 2001b. In case of quoting the actual words of another author, the page number should be provided, e.g. (Pivac, 2010, p. 23). If there are two authors, the surnames of both should be given (Pivac and Dragin, 2009). If there are more than two authors, the surname of the first

author only should be given, followed by et al. (Pivac et al., 2008). However, full names of all authors should be given in the list of references. The original journal title is to be retained in the case of publications published in any language other than English (please denote the language in parenthesis after the reference in the Reference list).

1. Book

a. Book (one author)

Format:

Author. (Year of publication). *Book title*. Place of publication: Publisher.

b. Book (two or more authors)

Format:

Author1., Author2., & Author3., (Year of publication). *Book title*. Place of publication: Publisher.

c. Book chapter or article in an edited book

Format:

Author(s) of chapter. (Year of publication). Chapter title. In Editors of the book (Ed.), *Book title* (Chapter page range). Place of publication: Publisher.

d. Proceedings from a conference

Format:

Author(s). (Year of publication). Title. In Conference name, Date (Page range). Place of publication: Publisher.

e. E-book

Format:

Author(s). (Year of publication). *Title*. Publisher. Retrieving date, http address. DOI.

2. Article

a. Journal Article (one author)

Format:

Author. (Year of publication). Article title. *Journal Title*. Volume (issue), range of pages. DOI.

b. Journal Article (two or more authors)

Format:

Author1., Author2., & Author3., (Year of publication). Article title. *Journal Title*. Volume (issue), range of pages. DOI.

c. Journal article from an online database

Format:

Author(s). (Year of publication). Article title [Electronic version]. *Journal Title*. Volume (issue), range of pages. Retrieved date of access, from name of database. DOI.

3. Other formats

a. Web page

Format:

Author/Sponsor. (last update or copyright date). *Title*. Retrieved date of access, from URL.
